A Generation of Fellows! This is the milestone we will reach with the Class of 2024. Quite an achievement. Just think of the impact that the Foundation and the more than 350 Fellows have had in these 20 years.

We often describe it in words. Here it is in numbers:

100,000 hours of Fellowship public interest and public service lawyering.

When we inaugurated the Public Policy Fellowship program with the Class of 2005, our six Fellows hailed from the laws schools at Georgetown, George Washington, Virginia and SMU. Two have been recognized and honored as Distinguished Fellows. Twenty years later, our Fellowship law schools total nineteen, plus the College d'Europe.

With the addition of the Sustained Impact Fellowships and the Joe Brand Human Rights Fellowship, the Class of 2023 had thirty Fellows. They worked more than 8000 hours in the public interest areas of racial and veterans justice, public defender and criminal law, human rights, international business and trade, access to justice, environment, children and crisis reporting, and working for state and US government offices.

2023 has been a very good and strong year. This brochure highlights the broad array of this year's Foundation programs and partnerships. It graphically shows the enlarging scope of our global footprint, features our Distinguished Fellows, heralds others in "Hooray for Our Fellows," recognizes and commends our Veteran Fellows, and reflects on the year in many photos. We are pleased with the successful efforts to strengthen our connections to our Fellowship alumni and productively blend them with the increasing number of lawyers, other professionals and staff in the firm who serve as mentors and members of the Advisory Committee.

In 2024, we will concentrate on continuing this work, pursuing new initiatives, and welcoming another talented and committed Fellowship class.

On the horizon is the Foundation's 25th Anniversary. We see that as an occasion to celebrate all that the Foundation has accomplished and contributed, and to step forward into our second 25 years with the confidence and aspiration that, "Together, We Can Do Even More".

Our Foundation

At the heart of our Foundation is our Public Policy Fellowship, which is approaching its twentieth year. Our Sustained Impact Fellowships began in 2019.

During this time, 356 Fellows have worked with public interest organizations and government offices in the US and across the world.

In 2023, the Foundation had 30 Fellows.

Three were Racial Justice Fellows, one was a Veterans Justice Fellow, one was our first Joe Brand Human Rights Fellow, one was a Pulitzer Center law and journalism Fellow, and 26 were Public Policy Fellows.

Together with the Deans and senior representatives from our Fellowship law schools, we pursue our commitment to engaging, inspiring and supporting law students to be the next generation of public interest advocates.

In 2018 the Foundation extended its Fellowship Program to Europe with the renowned public policy institute, Le Collège d'Europe. We have had five Fellows from its campus in Bruges, and one from its Warsaw campus. The College draws from all over Europe, and Fellows have come from Italy, France, Belgium, Germany, and Poland. Many, including this year's College Fellow, have interned at the European Union. Last year, our Fellow worked at the Warsaw Institute. Fellows from US law schools have done their Fellowships in Egypt, Guinea, Qatar, China, Thailand, Liberia, Uganda, Sierra Leone, Israel, Botswana, Palau, Switzerland, Costa Rica, England, Iraq, and the Hague in The Netherlands.


Ahmed Baset

Building on its contributions to the creation of the Sustained Impact Fellowship program, the Deans' Circle was instrumental to the formation of the Veterans' Justice Fellowship.

It also provides valuable overall guidance for the Fellowship program. Foundation Fellowship Programs

Public Policy Fellowships

The backbone of the Fellowship Program has long been our Public Policy Fellowship Program. Each year the Deans' Circle law schools' nominations for the Public Policy Fellowship Program are a unique blend of talented law students who bring a passion for public service directed at the country's most pressing issues. The Class of 2023 Public Policy Fellows worked for public defenders and on other aspects of criminal justice; for US executive and legislative offices, state governments, and the European Union; on environment, children's rights and access to justice; and on international business and trade.

Racial Justice Sustained Impact Fellowship Program

Three years ago, the Foundation established Fellowships focused on racial justice in the areas of police/minority community relations, juvenile justice reform in minority areas, and voting rights. These are Sustained Impact Fellowships that will continue.

In 2023, the Foundation partnered with the Citizen Complaint Authority in Cincinnati, the Lone Star Justice Alliance in Dallas, and the voting rights project at the Lawyers' Committee for Civil Rights in Washington. Our Racial Justice Fellows were, respectively, Sarah Jana, University of Cincinnati College of Law; Ernesto Castillo, LMU Loyola Law School, and Morgan Flitt, Georgetown University Law School.

In that case, won by Foundation President John Oberdorfer and others, a federal court in Washington DC struck down racial barriers to union membership faced by African American construction workers building the Washington DC Metrorail system.


