Summary of decision	<p>Proposal for nine turbines with a maximum blade tip height of 125m. The main issues in the appeal were the effects in relation to the underground mining operations, landscape and visual effects, ecological effects and effects on ancient monuments. The Inspector considered that the environmental impacts would not be significant, taking into account the mitigation measure proposed. However, the issue regarding the effect of the mining of coal beneath the appeal site was one that the Inspector did not feel could be overcome. The strong policy support for safeguarding access to coal outweighed the benefits of the proposal and the Inspector dismissed the appeal.</p>

The Reporter considered that when viewed next to the nearby An Suidhe wind farm, the difference in turbine size between the wind farms and different rotational speeds, together with the visual prominence of the proposal would be visually discordant and would significantly detract from the setting of Loch Awe, resulting in significant adverse landscape and visual effects. Overall, the Reporter considered that these impacts were sufficient to outweigh the benefits of the proposal.</p>

Summary of decision	<p>Proposal for a single wind turbine with a maximum blade tip height of 34.2 metres. The main issue was the effect on the character and appearance of the area. It was noted that the boundary of the AONB lie 900m north east of the site and lies within an area designated by the Council as a landscape conservation area. The Inspector found that the proposed turbine would appear as a dominant and intrusive feature within the local landscape, noting that it would be particularly visible from within a section of the AONB, such that it would not conserve the natural beauty of the area. Additionally, the Inspector also found that the proposed turbine would also be visible in combination with an existing turbine, adding cumulative harm to the landscape character and appearance of the area.</p>

The Inspector was of the view that the effects were not unacceptable and could be outweighed by the benefits.</p>

Overall, the Reporter found that the proposal would accord with the relevant provision of the development plan and that there were no material considerations which would justify refusing planning permission.</p>

The main issues were the effects on the setting of designated heritage assets and the effects on landscape character and visual amenity. The Inspector found that there would be less than substantial harm to the setting and significance of designated heritage assets. The Inspector noted that there would be significant adverse impact on landscape character and that the visual impact on those at Hemswell Cliff Primary School and the residents of Hemswell Cliff would be significantly greater than had been assessed by the Appellant. The Inspector recommended that the proposal be dismissed. The Secretary of State, additionally applied the transitional provisions of the WMS and was not satisfied that the planning impacts identified by local communities had been addressed. The Secretary of State agreed with the Inspectors recommendation and dismissed the appeal.</p>

The Reporter found that the proposed turbine would form a visually over-dominant feature in the open landscape, would result in a confusing and cluttered relationship cumulatively and that it would fill in a gap which is currently free of large turbines. Whilst the Reporter considered that the proposed turbine would result in some adverse visual impact on the nearest residential dwellings, it would not be so over-bearing as to be unacceptable. The Reporter concluded that the proposal did not comply with the Development Plan and that there were no material considerations to justify granting consent.</p>

Summary of decision	<p>Proposal for four wind turbines with a maximum blade tip height of 100 metres. The main issues were the effects on the character and appearance of the landscape, residential amenity and heritage assets. The Inspector noted that the proposed turbines would have a greater impact than the two turbines already permitted. However, he was of the view that the effects would not be incurred or noticed from further afield than for the two permitted turbines. With regards to residential amenity the Inspector found that the proposal would not have the effect as to make any of the nearby properties an unattractive or unpleasant place in which to live. The Inspector was of the view that the proposal would not have any effect on the significance of any heritage asset. Overall, the Inspector held that the benefits of the proposal outweighed the harms and recommended that the appeal be allowed. The Secretary of State however attached greater weight to the landscape and visual effects and in addition was of the view that the planning impacts identified by affected local communities had not been addressed. The appeal was therefore dismissed.</p>

The Inspector considered that although the proposed turbine would only have a moderate impact in the wider landscape, it would have a significant harmful effect in local views, especially when considered in conjunction with the existing turbines in the landscape. The Inspector noted that given the objectives of the WMS, she attributed greater weight to the landscape harms as these were also raised by members of the local community. The Inspector concluded that the benefits were not capable of outweighing the harms and dismissed the appeal.</p>

Summary of decision	<p>Proposal for the erection of a single turbine with a maximum blade tip height of 77 metres. The main issues were: (1) the effects on the character and appearance of the countryside and (2) the likely impact on living conditions. The Inspector considered that the proposed turbine would be a dominant structure and would have a high level of effect on the character of the local landscape. However, the Inspector was not of the view that the proposed turbine would result in wind turbines becoming the defining feature of the area. In terms of living conditions of nearby residents, the Inspector found that whilst the proposal would alter the living conditions for some, the changes would not justify refusing permission. The Inspector noted that there remained a substantial body of local opinion strongly opposed to the proposal and that an approval would therefore be at odds with the June 2015 Written Ministerial Statement. The Inspector therefore dismissed the appeal.</p>

The main issues were the effects on the landscape character and visual impact, on the AONB and on the setting of nearby heritage assets. The Inspector considered that the proposed turbine would only have a minor effect on the landscape character. However, the Inspector's view was that in the local landscape the proposal would be a very conspicuous feature. With regards to the AONB, the Inspector noted that although the proposed turbine would be 780m from the AONB, it would add a sense of visual clutter when viewed from the AONB. The Inspector also found there to be harm, albeit less than substantial harm, to the setting and significance of Capenwray Hall and Registered Park and Garden (1.2 and 1km from the appeal site). Overall, the Inspector held that the benefits of the proposal were not capable of outweighing the harms.</p>

Additionally, the Inspector was of the view that the proposal would erode the sense of remoteness and tranquillity being in close proximity to the heritage coast. The Inspector concluded that the benefits of the proposals did not outweigh the harms.</p>

The main issues were: (1) whether the proposed wind turbine would be inappropriate development in the Green Belt; and (2) the effect of the proposed turbine on the open rural character and visual amenity of the locality. The Inspector noted that the proposed development would be inappropriate development in the Green Belt. The Inspector found that, although the impact of the proposal would be limited to a small area, its impact on visual amenity and rural character would be significant. In assessing the overall planning balance, the Inspector noted that the proposal may help to alleviate the economic pressures on dairy farmers by helping to reduce ever increasing energy prices. The Inspector did not, however, consider that such benefits outweighed the overall harm that would result from the proposal. The Inspector noted that he had taken account of the Written Ministerial Statement and confirmed that the parties' representations in this regard had been taken into account, but that this did not affect the overall conclusion.</p>

The Inspector noted that the prominence of a tall structure with a sizeable moving element, such as the proposed development, would have a moderately harmful effect on the openness of the Green Belt. Although the Inspector agreed with the Appellant's assessment of the effect on landscape he concluded that the benefits did not amount to the very special circumstances to justify inappropriate development in the Green Belt. The Inspector noted that he had taken account of the Written Ministerial Statement, issued by the Secretary of State for Communities and Local Government on 18 June 2015, but confirmed that this did not alter his decision.</p>

The Inspector found the proposal would have a significant impact on the character and landscape of the local area. The Inspector also found that the proposal would have a significant visual impact and would affect the character of AONB. The Inspector concluded that, combined with the unacceptable noise levels that would arise, the benefits of the proposal were outweighed by the drawbacks. The Inspector found that the proposal would have a significant presence within the landscape up to approximately 2km from the site. The Inspector did not, however, consider that this would cause significant harm to the local landscape. As regards visual amenity, the Inspector found that the effects on those viewing the turbine from points beyond 3km were unlikely to be significant but that a degree of harm would be caused in certain areas. The Inspector turned to the benefits of the proposal and noted that these were insufficient to outweigh the harm that would be caused. The Inspector noted that he had taken account of the Written Ministerial Statement and confirmed that this was relevant to the present appeal, but that it had not altered his conclusion.</p>

The main issues were the effects, both individually and cumulatively, on the character of the landscape and on the visual amenity of the area, the effect of the proposed turbine on the setting and significance of heritage assets, the effect of the proposed wind turbine on aviation safety. The Inspector found that the proposal would be a prominent and intrusive feature that would have a substantial effect on the visual amenity of the area. The Inspector noted that the effect of the proposal on local heritage assets would result in less than substantial harm. The Inspector also considered that the potential threat to aviation safety that would undoubtedly arise as a result of the proposal should be taken into account. Having taken account of all the relevant factors, the Inspector concluded that the harm caused by the proposal would not be outweighed by the environmental benefits. The Inspector referred to the Written Ministerial Statement and confirmed that this was a material consideration which he had considered in the overall planning balance.</p>

The Inspector considered that although the proposal would have only a moderate impact upon the wider landscape, it would nonetheless have a significant harmful effect on character of the local area. As regards the living conditions of local residents, the Inspector found that the proposal would not conflict with Policy ENV1 of Selby District Local Plan and that this matter should not weigh against the proposal in the planning balance. However, the Inspector referred to the Written Ministerial Statement and noted that the lack of community backing should be given significant weight.
