

On January 31, 2024, the Department of Defense (DOD) [released an update](#) to the Chinese Military Company (CMC) List in accordance with Section 1260H of the National Defense Authorization Act (NDAA) for Fiscal Year 2021.

DOD added sixteen entities to the 1260H CMC List and removed three previously designated entities that no longer met “some or all of the statutory requirements” for inclusion on the CMC List. In an [accompanying press release](#), DOD emphasized that it would continue identifying and designating contributors to the People’s Republic of China’s (PRC) Military-Civil Fusion strategy that are operating in the United States.

Background

Section 1260H of the NDAA for Fiscal Year 2021 requires the Secretary of Defense to publish (until December 31, 2030) an annual list of Chinese military companies that are operating in the United States. Chinese companies operating directly or indirectly in the United States can be designated by DOD to the 1260H CMC List upon a finding by the DOD that the company is engaged in providing commercial services, manufacturing, producing or exporting, and is either:

- (1) Directly or indirectly owned or controlled by or acting as an agent of the People’s Liberation Army or any other organization subordinate to the Central Military Commission of the Chinese Communist Party, or
- (2) A military-civil fusion contributor to the Chinese defense industrial base. (“Military-civil fusion contributor” is broadly defined in Section 1260H of the NDAA to include “any other entities the Secretary determines is appropriate.”)

The 1260H CMC List was first released in June 2021 with the addition of over 40 Chinese companies. It was then updated in October 2022 with the addition of 13 companies.

Removal From the CMC List

There is currently no formal procedure for listed parties to seek removal from the 1260H CMC List. However, Section 1260H requires the DOD to make ongoing revisions to this list, including by deleting entities from the list “based on the latest information.” In fact, in the changes reported by DOD on January 31, three entities were removed for no longer meeting “some or all of the statutory requirements” of Section 1260H, which indicates that parties can be removed when DOD is presented with “latest information” showing the criteria for listing is no longer satisfied.

CMC Compared to Other “Chinese Military” Lists

The 1260H CMC List is different from the former DOD Communist Chinese Military Companies (“CCMC”) List established under Section 1237 of the NDAA for Fiscal Year 1999, which designated companies that were found to be owned or controlled by the People’s Liberation Army and engaged in commercial services, manufacturing, producing, or exporting. In 2021, pursuant to Executive Order 14032, the CCMC List was replaced by the Department of Treasury’s Non-SDN Chinese Military-Industrial Complex Companies (NS-CMIC) List identifying Chinese companies that operate in the defense or surveillance technology sector of the PRC economy as well as their parent entities and subsidiaries. Impact of Designation on the 1260H CMC List

Designation on the 1260H CMC List does not impose any direct restrictions as a consequence of being listed. In this way, the list does not function like the NS-CMIC List, for example, which prohibits certain U.S. person trading activities with the listed company. However, since the establishment of the 1260H CMC List, members of Congress have referenced the list to enact restrictions against listed companies, and, in some cases, against subsidiaries as well. For example, the NDAA for Fiscal Year 2024 prohibits DOD from entering into, renewing or extending a contract for the procurement of goods, services or technology with, or entering into, renewing or extending a contract for the procurement of goods or services that include goods or services produced or developed by a company on the 1260H CMC List or any entity subject to the control of such a listed entity (See National Defense Authorization Act for Fiscal Year 2024, Pub. L. No. 118-31, §805 (2023)). The latest law funding the federal government contains a similar provision applicable to procurement and other funding and contractual agreements with the Department of Homeland Security (See Consolidated Appropriations Act, Pub. L. No. 117-328, §539, 136 Stat. 4459 (2022)).

Furthermore, inclusion on the 1260H CMC List can result in indirect restrictions, such as the listed entity being viewed by exporters and reexporters of items subject to the US Export Administration Regulations (EAR) as “military end-users,” restricting certain items from being shipped without a license. Although not based on any legal restriction, some companies also have a policy to not do business with listed companies. As such, another significant consequence is that inclusion on the list may indirectly restrict the company’s supply chain as suppliers may seek to avoid perceived risks in dealing with a listed party.
