Lemuel Howard is a rising third-year law student at Howard University School of Law. Lemuel spent his summer as a legal intern for the Mid-Atlantic Innocence Project in Washington DC. As an intern, he was responsible for developing investigation strategies and researching trial materials in the pursuit of exonerating wrongfully convicted persons. This included going into the field and interviewing witnesses who were present at the scene of the crime, locating witnesses who may have recanted their testimony from the initial trial, and using DNA evidence to determine the guilt/innocence of the client if the case so required. Next fall, he will be participating in Howard Law's Fair Housing Clinic. Lemuel plans to pursue a career in public interest and civil rights work after graduation.



### Julia C. Lauritzen

The Ohio State University Moritz College of Law Catholic Charities Immigration Legal Services

Julia Lauritzen is a rising second-year law student at The Ohio State University Moritz College of Law. Julia worked for Catholic Charities Immigration Legal Services, part of Catholic Charities Migration and Refugee Services, in Cleveland, Ohio. During her internship, she prepared a variety of immigration applications, including applications for naturalization, permanent residency and humanitarian petitions. She also worked extensively on an asylum brief for an unaccompanied child in removal proceedings. Julia hopes to pursue a career in public interest immigration law.



### **Claire Cahoon**

The Meadows Mental Health Policy Institute

Southern Methodist University, Dedman School of Law

Claire Cahoon is a rising second-year Hatton W. Sumners Scholar at Southern Methodist University Dedman School of Law. Claire spent her summer with the Meadows Mental Health Institute, a nonpartisan policy research and development institute seeking to improve mental health services in Texas. As a member of the Smart Justice team, Claire worked to improve overall public safety by reducing the number of people with mental illness who receive treatment through involvement with law enforcement. She researched and drafted policy recommendations for the Texas Judicial Mental Health Commission and Texas legislature. She also performed hands-on criminal justice reform, communicating directly with law enforcement about assisting persons who may be experiencing a mental illness.

Barbara Horne-Petersdorf is a rising 3L at The George Washington University Law School. She spent her summer at the United Nations International Law Commission, which consists of 34 independent international legal experts tasked with codifying and developing international law. As a research assistant to the Egyptian member, Ambassador Dr. Hussein Hassouna, Barbara conducted research and wrote on topics currently under consideration by the Commission. These include identification of customary international law, protection of the atmosphere and succession of states in respect of state responsibility, among others. Specifically, Barbara wrote memoranda analyzing each topic and drafted statements made by Dr. Hassouna before the Commission and the General Assembly.

**Peace at Home Family Shelter** 

Katie Rose Martin is a rising third-year law student at the University of Arkansas School of Law. Katie Rose worked with Peace at Home Family Shelter in Northwest Arkansas. Peace at Home was the first shelter in Arkansas to provide shelter and supportive services for victims of domestic violence. Katie Rose's project addressed policy issues surrounding the unique interrelationship between the needs of victims of domestic violence and Arkansas' landlord-tenant laws. She also helped Peace at Home identify affordable housing solutions for their fast-growing region and developed a quick-reference guide to assist public housing providers to understand and comply with the law.

## UN High Commissioner for Refugees, Caribbean Protection Unit

Elisa Vari is a rising third-year law student at the University of California, Hastings College of the Law in San Francisco. She spent her summer interning for the United Nations High Commissioner for Refugees (UNHCR). At UNHCR, Elisa worked within the Caribbean Protection Unit, where she drafted Refugee Status Determinations, appeal decisions, monitored the development of asylum and refugee legislation in the Caribbean region, and researched country conditions. After law school, Elisa plans to pursue a career in refugee, asylum and human rights law.

Joaquin Ray Gallegos is from the Jicarilla Apache Nation and Pueblo of Santa Ana. Over the summer, he served as a legal intern with the US Senate Committee on Indian Affairs, Office of the Vice Chairman. Joaquin assisted in developing policy on a number of issues under the Committee's jurisdiction involving the unique status of American Indian, Native Hawaiian and Alaska Native peoples, including education, economic development, land management, federal trust responsibilities and healthcare. Following graduation, Joaquin aims to serve as a judicial clerk and then, in practice, advance Indian law and policy priorities to reshape the place of Indian Tribes in US jurisprudence.

## The Nature Conservancy

Edwin LaMair is a rising 2L at the University of Denver, Sturm College of Law. Edwin worked at The Nature Conservancy, an international environmental non-profit. At the Conservancy, his work included research on state carbon emission and exchanges legislation, recreational use statutes and best liability practices, and antibribery regulations in Caribbean nations. His memoranda, training slides and research will be used to assist various branches of the organization in their mission to conserve the lands and waters on which all life depends. Edwin plans to pursue a career in public interest environmental law.

In her position at One-Stop, she helped provide direct legal service to community members, and develop and strengthen community structure through events such as community workshops. In the fall, Catalina will begin an LL.M. in real property development, which she hopes will further her dream of creating affordable housing for communities in need throughout Miami.

Hannah worked at the Texas Association Against Sexual Assault in their Incarcerated Survivor Advocacy Program. Throughout the summer, Hannah conducted legal research on sexual assault laws to determine laws that need to be passed to fill in gaps where help to survivors is still deficient. Hannah also reviewed cases of incarcerated individuals who have been sexually abused in correctional facilities to provide them with resources and tools to ensure their safety.

Geoffrey Schmelkin is a J.D./M.B.A. candidate at the University of Virginia. He spent his summer fellowship at the US Trade and Development Agency, an independent government agency that works to build infrastructure in developing and middle-income countries with the help of US businesses. In his role, he supported the Office of General Counsel in providing advice on the legal aspects of the agency's projects around the world. He analyzed issues arising under federal laws related to trade and foreign assistance, interpreted administrative statutes and regulations, and drafted contracts to provide funding for infrastructure projects across the globe.



### **Dianne Lake**

**Public International Law and Policy Group** 

Yale Law School

Dianne Lake is a rising second year at Yale Law School. She spent her summer working for the Public International Law and Policy Group (PILPG), a global *pro bono* law firm. Dianne helped Yemeni civil society organizations strengthen their capacity to effectively advocate on behalf of citizens. She also put together presentations and training materials, and her research and writing focused on ensuring women, youth and persons with disabilities have greater political engagement and representation. Dianne assisted PILPG's work with government of Kenya officials and civil society organizations to support their efforts with domestic accountability for politically motivated human rights abuses.

## **Foundation History**

- **2000** Foundation was established, endowed with the firm's awarded attorneys' fees from the *Ironworkers pro bono* case. In that case, won by Foundation President and Vice Chairman John Oberdorfer, a federal court in Washington, DC struck down racial barriers to union membership faced by African-American construction workers building the Washington, DC Metrorail system.
- **2003** Foundation establishes the Public Policy Fellowship program.
- **2004** Foundation awards first Public Policy Fellowships to Georgetown Law Center and The George Washington University Law School students.
- **2005** Foundation establishes the Foundation's Advisory Committee.
- 2007 Our Public Policy Fellowship program grows to 11 law schools.
- **2010** First "Issues of Our Time" event launched. Speakers since 2010 have included James Wolfensohn, former president of The World Bank; Ambassador Frank Wisner, International Affairs Advisor at Squire Patton Boggs LLP; and Senators Cory Booker and Ted Cruz.
- **2012** The 100th law student participates in the Public Policy Fellowship program.
- **2013** Our Public Policy Fellowship grows to 15 law schools. First Qatar law student awarded fellowship.
- **2014** Foundation and the University of Colorado join forces to offer the first post-graduate fellowship. Squire Patton Boggs launched.
- **2016** Symposium on Combatting Poverty. Luncheon to honor Qatar Ambassador and Fellows from Qatar.
- 2017 200th law student participates in the Public Policy Fellowship program. "Foundation Moments" established. Foundation joins forces with the Russia-United States Legal Education Foundation to sponsor a Russian student at The George Washington University Law School.
- **2018** Expansion of Public Policy Fellowship Program to Europe with the Collège d'Europe in connection with the Brussels office.

Welcomes the University of Arkansas Law School to the Fellowship Program.

Meeting of Fellowship Law School Deans and formation of Deans' Circle.

Addition of four Fellowship Alums to Advisory Committee.

10th "Issues of Our Time" program, with EU Ambassador David O'Sullivan and European Public Policy Leader Wolfgang Maschek discussing the future of the Atlantic Alliance.
