## **Speaker Biographies**



**Kelly Simmons OBE**Sports Consultant and former FA Director of the Women's Professional Game, 2018-2023

Kelly Simmons OBE is a world leader in football with over 30 years of experience in the English Football Association (The FA). From 2018 to 2023, Kelly was the director of the Women's Professional Game for the FA in England, where she led the transformation of the women's professional game in England into one the world's leading domestic systems, including the transition of the Women's Super League (WSL) into a fully professional league and securing record sponsorship and media deals. Prior to this, Kelly was director of development for The FA, overseeing the delivery of a £200 million four-year plan for children's and grassroots football. Kelly is a Non-Executive Director of Women in Football and is now a consultant working with FIFA, Portas, Run Communications and Premiership Women's Rugby.



Tammy Parlour MBE Co-Founder and CEO Women's Sport Trust

Tammy Parlour MBE co-founded Women's Sport Trust in 2012 and leads the organisation as CEO. Tammy's role involves working with leaders from across sport, media and business to understand how to practically raise visibility, increase impact and create a stronger women's sport ecosystem. She was awarded an MBE in the New Year 2019 Honours List for services to gender equality in sport. Tammy is a master in the Korean martial art of Hapkido, having practiced for over 40 years. She set up her own Hapkido and meditation school in the early '90s and still coaches regularly. Tammy holds an MSc in strength and conditioning, and post-graduate study into applied sport psychology. With an interest in women's football, she also volunteers as a board director for her local team – AFC Wimbledon Women FC – and sits on The FA Women's National League Board as a Club Representative.

Thayer Lavielle is the executive vice president at The Collective, Wasserman's practice focused on creating change for equity and fairness for women through unique insights, ideas, campaigns and activations. Holly Wood is a former dual code rugby player, having represented England in rugby league and Richmond, Harlequins and Toulouse in union, including winning three premiership titles. In 2020, Holly retired from playing and immediately started refereeing. By 2021, she was involved in refereeing in the Allianz Premier 15s, and by 2022 she refereed at the Birmingham Commonwealth Games. Having fallen pregnant in September 2022, Holly continued to referee until March 2023, when she officiated at Twickenham. At that time, she spearheaded and wrote a maternity policy for the RFU to cover all female match officials in England. Since giving birth in June 2023, she went onto referee her first test match in the September, gained promotion onto the National Panel and continues to be an advocate for change, to ensure a fully inclusive environment across all levels of rugby in England. Holly has taken pride in travelling the world refereeing, with her son, and donating excess breastmilk to hospitals abroad, during competition, showing that motherhood and being an athlete can coexist. Outside of rugby, Holly enjoys walking her dog, reviewing games with her (also) referee husband and teaching her baby son the ropes at the gym.


