To the Class of 2025, Fellowship Alumni, and Friends of the Foundation,

In this, our Silver Anniversary Year, we have the pleasure of introducing you to the spectacular 33 Fellows in the Class of 2025. Six Sustained Impact Fellows and 22 Public Policy Fellows are in this summer's program. In addition, five are Justice Jump Start Fellows who just graduated and are headed to public interest and government service careers after their bar exams. They bring the total number of Fellows to 419.

This is a very committed class with a broad range of experiences and interests. To highlight a few:

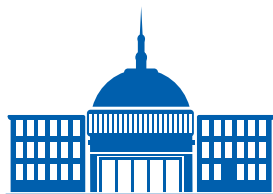

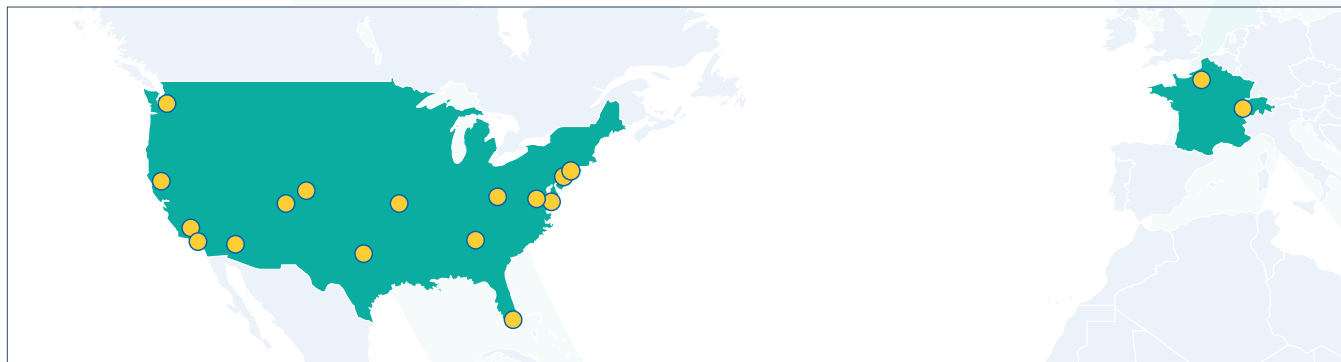

Lawyers' Committee on Civil Rights Under Law

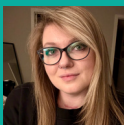
