Dear Colleagues, Fellows, Deans and Friends of the Foundation,

This has been an exhilarating year of celebration of the Foundation's Silver Anniversary and our many achievements. This commemorative report highlights our 25-year history and accomplishments, while also shining brightly on 2025.

This year's 33 Fellows brought the total number of Fellows we've supported to 419. We are proud of all our Fellows and the invaluable support they have provided to hundreds of nonprofit legal organizations and government offices, ultimately benefiting countless numbers of people in the United States and across the globe.

This year, we took several new steps and built on existing ones:

- We doubled our Sustained Impact Fellowship commitment to veterans' justice,
- We revived the "Issues of Our Time" series with a session on the tariff cases,
- We added the Scalia School of Law to our list of Fellow law schools, and
- We announced a new Rural Justice Fellowship in southeast Ohio to respond to the need for lawyers in underserved rural communities.

The celebration of our 25th reached a crescendo in July with moving speeches by Squire Patton Boggs' Fred Nance and Dean Cynthia Nance of the University of Arkansas Law School, plus three energized panels. We capped off the year with our Distinguished Fellow and Distinguished Service Awards, recognizing three inspiring leaders.

We received a warm celebratory embrace from Firm Leadership, especially appreciated as we navigate a period of shifting winds. Scores of you have engaged with the Foundation—on the board or on committees, as mentors, and as financial contributors. Thank you!

As we begin the Foundation's next 25 years, much lies ahead. We will continue to inspire and assist Fellows to become leaders. Celebrating 25 Years

History

The Foundation was established in 2000, endowed with the Firm's awarded lawyers' fees from the Ironworkers *pro bono* case. In that case, won by Foundation President John Oberdorfer and others, a federal court in Washington DC struck down racial barriers to union membership faced by African American construction workers building the Washington DC Metrorail system. Inspired by Tom Boggs, the Fellowship Program began in 2005.

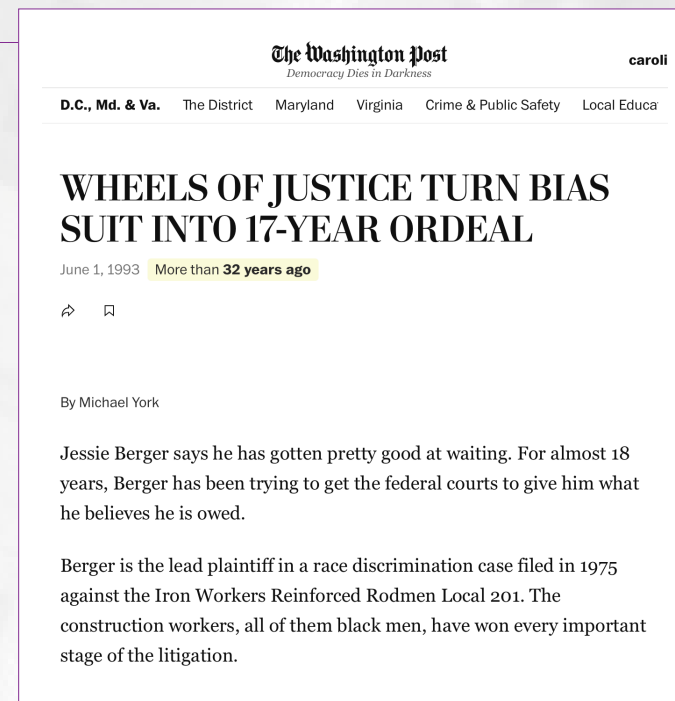
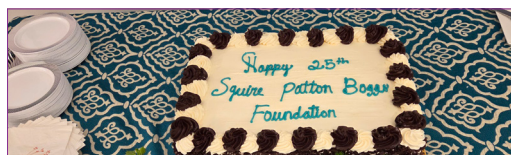

Laura Graham

Laura Graham, an alumna of the 2019 Fellowship Class, served as a Visiting Professional at the International Criminal Court in The Hague. Dr. Graham is a graduate of Case Western Reserve University School of Law (JD '21), Aberdeen University Scotland (PhD '13), earned several master's degrees, and was an Assistant Professor of Peace and Justice Studies at Tufts University and Trinity College Dublin. Since 2021, Dr. Graham has worked in national security law at the FBI Office of the General Counsel in Washington, DC. She is currently team lead for the domestic terrorism legal team, and an ultra marathoner.

In 2018, the Foundation extended its Fellowship program to Europe with the renowned public policy institute, Le Collège d’Europe. We have had five Fellows from its campus in Bruges, Belgium, and one from its Warsaw campus. Le Collège draws from all over Europe, and Fellows have come from Italy, France, Belgium, Germany, and Poland. Several interned at the US desk at the European Union. One worked at the Warsaw Institute. Fellows from U.S. law schools have served in 24 countries across five continents. Three Fellows from Qatar also have participated in our program. Our Fellowship Programs

Public Policy Fellowships

The Foundation's flagship program is the Public Policy Fellowship program, offered each summer to one or more deserving students selected by each of our partner law schools and the Collège d'Europe's public policy institute. At each partner school, students apply for the Fellowship to fund their proposed work with a nonprofit legal organization, NGO or governmental agency. Each selected Fellow receives a stipend, and is mentored by a current or former Squire Patton Boggs attorney, as well as a Fellowship alum. The Foundation also organizes activities throughout the summer to enable the Fellows to learn about their colleagues' Fellowships, discuss issues of common interest, and develop strategies for pursuing career opportunities in the public interest/public policy field. To date, our Public Policy Fellows have served well over 300 governmental and public interest institutions.

Justice Jump Start Fellowships

Initiated in 2024, the Justice Jump Start Fellowship incentivizes graduating law students to begin their careers in public service/public interest law. This Fellowship helps bridge the period between graduation and bar examination passage by funding bar exam and preparation expenses, and partnering with organizations that would provide interim public service work. Eight Justice Jump Start Fellows (three in 2024 and five in 2025) have gone on to work at prosecutors' and public defenders' offices, a state attorney general's office, and immigration and general legal aid clinics. The Foundation plans to expand this program in 2026 and beyond.

Sustained Impact Fellowships

The Foundation grants Sustained Impact Fellowships each summer to Fellows selected on a competitive basis from nominees by our partner law schools. Currently, the Sustained Impact Fellowships are:

- **Advancing Justice Fellowship** with the Lawyers' Committee for Civil Rights Under Law (Washington DC) (voting rights or educational opportunities);
- **Advancing Justice Fellowship** with Lone Star Justice Alliance (Dallas/Austin) (juvenile justice in disadvantaged communities);
- Two **Veterans Justice Fellowships** with Swords to Plowshares (San Francisco, CA) (assistance to veterans, particularly securing veterans' benefits);
- **Human Rights Fellowship** with Human Rights Watch (Washington DC) (investigating and reporting on human rights abuses globally); and
- **The Joe Brand Human Rights Fellowship** with Human Rights First (Washington DC) (promoting respect for human rights and the rule of law in the United States and globally).

In 2026, we will add a **Sustained Impact Rural Justice Fellowship** with Legal Aid of Southeast and Central Ohio (legal services in rural areas of Southeast Ohio where there are an insufficient number of lawyers to serve the needs of low income residents).



The Sustained Impact Fellowship with Human Rights First was created to honor the late Joe Brand—Squire Patton Boggs partner, Foundation Board member and devoted pro bono advocate for human rights throughout his nearly 60 years of legal practice.
