In the energy and natural resources industries, he has led global transactions applying renewable power technologies (wind, solar and geothermal), as well as conventional fuel power plants, hydrogen fuel cell projects, lithium and other critical mineral extraction projects, battery energy storage systems and fuel transportation and storage projects.

In the transportation industry, Alvaro represents rolling stock and electrical vehicle manufacturers and has advised on Public-Private Partnership (P3) light-rail urban transportation projects and toll road projects.

This project work has informed his broad understanding of how business is conducted in Mexico and has formed the basis of his long-standing relationships with top-level business, industry and legal professionals in the country.

- Advising a member of the shareholder group for the Manzanillo liquefied natural gas (LNG)-to-power complex, which includes two combined-cycle power plants – each with a net installed capacity of approximately 420MW – and an LNG reception, storage and regasification facility capable of supplying gas-fired power plants with up to 800MW of capacity, located near the Port of Manzanillo in the Dominican Republic.
