- Defending a claim brought by two unions for a protective award for an alleged failure to collectively consult involving liability of £1.5 million.

- Advising on Whistleblowing investigations
- Multijurisdictional restructures/reduction in workforce processes, involving project management across different countries to ensure a joined-up approach and transparent timeline.
