About Cole

With an over three decades-long career in the public and private sectors, Cole Wist is a creative problem solver, a seasoned litigator and a principled, dedicated advocate. Cole has represented clients in complex litigation and policy matters across the US and has served his community and state as an elected official. Over the course of his professional career, Cole has filled critical leadership roles in the legal profession, state government and the non-profit sector.

Recognized as one of Colorado's top labor and employment attorneys, Cole engages in a national practice, representing businesses and employers in a variety of matters, with a special emphasis on regulatory enforcement, workplace safety and health, crisis risk management and whistleblower litigation. He is regularly called upon to advise and defend employers in high-stakes litigation on a wide range of matters following occupational accidents and emergencies, and he has appeared as counsel of record in state and federal courts in over 30 US states. Cole has significant courtroom and arbitration experience and, as first chair counsel, has tried numerous complex cases to verdict. In addition to his litigation practice, Cole represents clients in regulatory enforcement matters before administrative agencies, including the Occupational Safety and Health Administration (OSHA), Mine Safety and Health Administration (MSHA), Pipeline and Hazardous Material Safety Administration (PHMSA) and Chemical Safety Board. Cole advises and trains employers regarding inspection strategies, liability prevention and crisis management. His experience also includes representation of employers on discrimination, retaliation and whistleblower claims.

In his public sector career, Cole served two terms in the Colorado House of Representatives and was selected as Assistant Minority Leader by his peers. During his tenure in the Colorado General Assembly, Cole served on the House Judiciary Committee, the House Business Affairs and Labor Committee and Legislative Council. Cole earned a reputation as a productive, bipartisan lawmaker who was not afraid to take on tough issues. He played a critical role in the passage of several landmark pieces of legislation, including: a bill to reform Colorado's judicial performance evaluation system; Colorado's sweeping data privacy and breach notification statute; a bill to reform the state's construction defect litigation process; a law creating an alternative dispute mechanism for open records disputes; and a civil rape shield statute to protect victims of sexual assault. Cole also represented Colorado as a Commissioner on the influential Uniform Law Commission, which provides states with non-partisan, well-drafted legislation that brings clarity and stability to legal

reform and state statutory law. Cole's legislative accomplishments and policy work have been recognized by national and state organizations, including Colorado Coalition Against Sexual Assault, Colorado Civil Justice League and Mental Health America.

Cole's public service continued after serving in elected office. Following an appointment by the Colorado State Senate, he served as Chair of the Colorado Independent Ethics Commission.
