During his tenure, Michael was the senior lawyer for a business unit with US\$35 billion in annual revenue. He also oversaw the international legal matters and international trade and commercial issues, including its international arbitration matters. Prior to this, Michael had a lengthy career in international affairs, first as an active-duty lawyer with the US

military specializing in international law, a tenure that included tours of duty in Korea, Panama, Honduras and the Pentagon, and then as an international trade lawyer in the Office of General Counsel at the US Department of Commerce.

Following his government service, he joined the Washington DC office of a large global law firm, where he was a partner in the International Trade Practice. Between 2003 and 2012, while still affiliated with the firm, Michael relocated to Chile, where he spent nine years as an investor in and director of several food- and food-ingredient production companies and was counsel to an international law firm based in Santiago.

In his work with global commodity companies, Michael helps provide or coordinate the full range of legal services on all aspects of international trade and shipping across all commodity sectors, including advising and assisting with contracts and structuring transactions, corporate matters, trade finance, litigation and arbitration, regulatory or policy matters, environmental law, derivatives and international trade compliance and investigations.
