Eligiusz Krzeńskiak is the managing partner of our Warsaw office and professor and chair of the Commercial Law Faculty at the Lazarski University in Warsaw, where he teaches business law and arbitration. His practice focuses mainly on arbitration and regulated sectors, including some of the largest projects in those areas in the recent years in Poland.

In the past he served as the deputy chairman of the seven-person Supervisory Board of PKO BP, the largest Polish state-controlled bank with over 25,000 employees, and as a member of the nine-person supervisory board of PZU S.A., the largest Polish state-controlled insurance group with close to 40,000 employees. He was also the chairman of the Supervisory Board of Alior Bank, another leading Polish bank, listed on the Warsaw stock exchange.

He is the author of over ten books and over 100 articles, published in leading peer-reviewed journals on legal topics.
