About Hin Han

Hin Han Shum is a solicitor advocate, able to be heard in the High Court and Court of Final Appeal. She has conducted various litigation cases and has represented clients in interlocutory applications in the District Court and High Court. She is heavily involved in the commercial and corporate practice and has experience in mergers and acquisitions and contract drafting. With a special interest in legal compliance on the use of technological tools, Hin Han often advises clients on data privacy laws, drafts privacy policies and website terms, as well as agreements relating to apps, tools and their roll out, and provides practical solutions in relation to cybersecurity incidents.

Having previously served as solicitor in various civil litigation proceedings and qualified as an accredited general mediator, Hin Han is familiar with the common fundamental issues leading to disputes and aims to prevent those risks at the contract preparation and corporate structuring stage. She is admitted as an associate member of the Hong Kong Institute of Arbitrators and formerly sat on the Steering Committee on Mediation under the Department of Justice. She is empaneled as an arbitrator of the Asian-African Legal Consultative Organization (AALCO) Hong Kong Regional Arbitration Centre, an inter-governmental organization that has 48 member states.

She has been seconded to an international securities firm and international telecommunications companies, to assist their in-house legal teams with day-to-day operations and major transactions. These experiences have allowed her to develop a pragmatic approach to solving business operation issues.

Hin Han has experience with handling a range of criminal cases, including white-collar investigations. She is also qualified as a prosecutor on fiat for the Department of Justice.

She has been appointed as a Chairman of the Appeal Tribunal Panel (the Buildings Ordinance) since 1 December 2021, and sits on Criminal and Law Enforcement Injuries Compensation Boards, and is a lay assessor of the Medical Council of Hong Kong.

Hin Han is currently an officer of the International Bar Association (IBA) Young Lawyers Committee. Formerly, she was an officer of the IBA Online Services Committee, Professional Ethics Committee and Anti-Corruption Committee. She also sits on the Council of the Law Society of Hong Kong, the

regulatory body of Hong Kong solicitors and serves as a member of various committees, including the Standing Committee on Compliance and External Affairs, Anti-Money Laundering Committee, Sports Law Committee, Arbitration Committee and Mediation Committee.

Hin Han publishes widely on topics including partnerships, sports law, data privacy, cybercrime, blockchain, artificial intelligence, technology, anti-money laundering rules and labour and discrimination matters. She has also authored data privacy practical guidance content for LexisNexis, co-authored the Hong Kong chapter of *IEL Sports Law* (published by Kluwer Law International), and has contributed to the *Annotated Ordinances of Hong Kong: Business Registration Ordinance* (Cap 310) (third and fourth editions, published by LexisNexis Hong Kong) and to the *Butterworths Hong Kong Partnership Law Handbook* (second and third editions, published by LexisNexis Hong Kong).

She is often invited to speak at international conferences, community events and universities on topics as data privacy and blockchain, cybercrime, mergers and acquisitions, artificial intelligence in businesses and family law. She is currently a part-time risk management tutor for Hong Kong lawyers.

Apart from work engagements, she enjoys contributing to the community and has been awarded the 4th Leadership Bauhinia Award, the Gold Award of the Hong Kong Law Society Pro Bono Community Work Recognition and the Professional Volunteers Accreditation Recognition Programme Leadership Award and the Gold Award.

She was also a finalist of the Asia Legal Business Hong Kong Law Award 2023 for the Taylor Root Award Young Lawyer of the Year.
