Employment Litigation

- Acting for a large retailer on a long-running equal pay dispute.
- Representing a US technology company on a multi-million pound dispute involving alleged theft of the confidential information of one of its main competitors.
- Acting for a UK Forex company on claims against a group of former employees involving breaches of their restrictive covenants and theft of confidential information.

Civil Fraud
