For the last 30 years, he has been a leading authority on Ohio port authorities, often representing them in transformational development finance projects and programs, including the first structured lease financings by Ohio port authorities, creation and development of common bond fund programs to provide credit support for economic development financing, legislative efforts to enhance the capabilities of Ohio port authorities to support development projects, and developing other innovative structured financings or programs.

Jeff serves as bond counsel, general counsel and special counsel to Ohio port authorities, and as bond and special counsel to other governmental bodies and companies, in structuring and implementing financings for real estate and other multi-party development transactions, including cooperative tax increment and special assessment financings, capital and operating lease financings, new markets and historic tax credit financing, PACE financing, and financings involving unique structured public credit support and other features.
