- Obtained dismissal of multiple foreign-law claims against Middle Eastern financial institution by alleged victims of terrorism. *Licci v. Lebanese Canadian Bank*, SAL, 505931/2015 (N.Y. Sup. Ct. June 28, 2023), appeal pending, 2023-10449 (N.Y. App. Div.).
- Representing international financial institutions in multiple federal lawsuits involving claims arising under Anti-Terrorism Act.
- Regularly advise international financial institutions on issues including regulatory compliance, sanctions, correspondent banking and foreign bank secrecy.
