She has obtained contempt of court orders, including penal sanctions against defendants breaching High Court injunctions. She also regularly represents clients in court challenges and appeals from arbitration awards.

Katie has spoken at international grain conferences and delivered international training courses on commodity trading and shipping for GAFTA. She supports events and initiatives highlighting the role of women in the law and in the shipping and commodities industries.
