Kiera has obtained injunctive relief from the courts to allow electricity distribution companies to access land in several cases.

She also has extensive experience in bringing injunction proceedings against protestors and trespassers, particularly on large and complex sites. Kiera has successfully acted to protect client interests by securing urgent relief to prevent unlawful activities, minimise disruption and safeguard business operations.

Kiera advises on a wide range of claims brought in the High Court and Upper Tribunal (Lands Chamber). She also has experience in Alternative Dispute Resolution, such as mediation.
