Throughout her time on Capitol Hill, Mara worked on several marquee pieces of legislation, including healthcare, environment and water, and banking and financial services.

Mara serves as the State of Colorado's Federal Liaison at the National Governors Association (NGA), where she has been the conduit for the state with both the Trump and Biden administrations and the nation's governors.

Prior to joining the firm, Mara served as Communications Director and spokesperson for Governor Jared Polis' successful gubernatorial campaign. Over the last two decades, she has worked both nationally and locally on political campaigns, including presidential races, serving in senior roles for statewide candidate elections and at the grassroots level on state and local ballot initiatives.

Mara currently serves on the Advisory Board for KEY Investment Partners LLC, and previously on the Board of Directors for the Colorado Hemp Association, as a Trustee on The Summit Foundation Board of Directors, the Boards of Directors for Rose Women's Group, a Rose Community Foundation donor-advised fund in Denver, Colorado, and Team Breckenridge Sports Club in Breckenridge, Colorado.

Mara graduated with a Bachelor of Journalism from the University of Missouri-Columbia School of Journalism, and a Minor in Political Science. She regularly writes commentaries on state and federal policy issues, particularly on cannabis and hemp. Her articles have recently been published in *Politico, The Denver Post, Colorado Politics, Law360, Cannabis Law Report* and *Cannabis Law Journal*. Many of her articles are further distributed by news aggregators such as the *National Law Review* and Lexology.
