### About Peter

In addition to foreign investment reviews, Peter has over 15 years of experience counseling on complex compliance obligations and risk mitigation strategies related to national security regulatory regimes. Peter's experience in these areas has included advising on compliance matters under the Export Administration Regulations (EAR) and Export Control Reform Act (ECRA); International Traffic in Arms Regulations (ITAR, 22 CFR 120-130); the Executive Order on Securing the Information and Communications Technology and Services (ICTS) Supply Chain (EO 13873, May 15, 2019) and implementing regulations (15 CFR 7); sanctions administered by the Office of Foreign Assets Control (OFAC) of the US Treasury Department, including the Non-SDN Chinese Military-Industrial Complex Companies List under EO 14032 and related Chinese military company lists; addressing Foreign Ownership, Control or Influence (FOCI) issues and mitigation arrangements under the National Industrial Security Program (32 CFR Part 117); and the Foreign Corrupt Practice Act (FCPA).

Peter is the recipient of the prestigious Burton Award. The Burton Award is supported by the Library of Congress and awarded to attorneys who have demonstrated achievement in the law and legal writing. Peter is a frequent speaker and commentator on issues relating to foreign investment screening and national security compliance strategies.
