Robb is a leading member of the firm's C-band relocation payment clearinghouse team, which is administering the reconfiguration of the C-band to make available 300 MHz of spectrum for flexible use of wireless services, including 5G. He served in a similar role with the firm's 800 MHz Transition Administration team, which has administered the reconfiguration of more than 2,000 wireless networks to improve public safety communications and to minimize increasing levels of interference caused by having both commercial wireless cellular systems and critical public safety communications systems operating in the same band. Leveraging his prior experience as a Certified Public Accountant (qualified in 1991) and auditor, Robb has worked closely with the clients to resolve complicated financial aspects of the programs, including cost review, audit, financial statement and program financial security issues.
