Sabina also regularly assists clients with employment law aspects of due diligence processes.

In addition to her employment law expertise, Sabina is also proficient in compliance issues, covering not only whistleblowing processes and related obligations, but also assisting in sensitive corporate investigations and grievance processes, having advised major global firms on both domestic and cross-border projects. Consequently, she also regularly assists in data protection matters. Additionally, Sabina offers advisory services in relation to intellectual property rights, delivering strategic solutions, as well as support for the protection and enforcement of intellectual property within organisations.
