Fraud

- The "moths" case: Acting for the purchasers of a £32.5 million property in successfully obtaining rescission of the sale due to the vendor's fraudulent concealment of a moth infestation. (Patarkatsishvili v Woodward-Fisher [2025] EWHC 265 (Ch))
- Successfully acted for an administrator in obtaining a freezing injunction with a limit of £20
 million against a former director and related subsidiaries. The claims involved dishonest breaches
 of fiduciary duty, including fraudulent drawdowns on an asset finance facility and
 misappropriating funds.
