# **About Stephen**

Stephen Sampson is the head of our UK Litigation Practice and the industry group leader and an EMEA lead of the Sports & Entertainment Group. He is widely recognised as one of the leading sports and entertainment lawyers in the industry. He advises on a wide range of regulatory, contentious and commercial issues, including disputes, investigations and transactions, acts as advocate before sports tribunals and holds external positions within the sector.

Stephen has practised in the sports, media and entertainment sector for almost 30 years. He has been ranked in band one or above in the legal directories for over a decade. He sits as a CAS arbitrator and is the vice chairman of the UEFA Club Financial Control Body Appeals Chamber. He was formerly (*pro bono*) chairman of Parkour Earth and (*pro bono*) a member of the World Triathlon Tribunal.

His work in investigations includes leading the review team or advising the party subject to investigation on issues such as financial wrongdoing, financial compliance, corruption, sexual abuse, racism and ownership. His advisory and disputes work includes contracts, economic torts, agency law, restraint of trade, public law standards, data rights, disciplinary charges, competition law in the sports sector, the employment of players, coaching staff and executives, regulatory compliance and regulatory aspects of corporate transactions, arbitration proceedings and specialist sports tribunals in England and elsewhere and heavy High Court litigation, including interim relief. He has acted in many cases that have helped shape the sports industry in the UK and Europe.

Stephen leads and manages our UK and European Litigation Practice Group and our worldwide Sports & Entertainment Group. He started as a trainee solicitor with the firm in 1998 and mentors and develops colleagues through their career progression.
