Her *pro bono* work includes winning clemency from a life sentence for a client who had no history of violence, US citizenship for several soldiers enlisted in the US Army who would face persecution if sent back to their home countries and backpay for a non-English-speaking electrician preyed upon by a bonded contractor. Victoria focuses her current *pro bono* efforts on winning monetary damages for victims of child sexual abuse from their convicted abusers.
