#### Litigation

- Representing a major Czech and CEE industrial group operating in aluminium, metallurgical and machinery industries in relation to an insurance coverage dispute.

- Representing a supplier of electricity and natural gas in a series of court proceedings involving claims of significant financial value.
- Represented a major US manufacturer and distributor of automotive oils, additives and lubricants in a complex cross-border court dispute with its customer dealing with supply chain issues from various EU and non-EU markets and jurisdictions.
