

CHANGES TO THE IMMIGRATION RULES FROM 6 APRIL 2014

Changes to Tier 2

- Tier 2 (ICT) and Tier 2 (General) applicants may now be granted up to five years' leave, rather than three.
- Changes to salary requirements. The minimum appropriate rates for skilled workers in each occupation SOC Code and the overall salary thresholds across Tier 2 have increased in line with wage inflation. The following minimum salary thresholds apply to all Certificates of Sponsorship (CoS) issued on or after 6 April 2014:

Tier 2 (Intra- Company Transfer)	Short Term Staff, Skills Transfer or Graduate Trainee categories (maximum stay 6 months (Skills Transfer) or 1 year (Short Term & Graduate Transfer))	£24,500
Tier 2 (Intra- Company Transfer)	Jobs which qualify for the Long Term Staff category (maximum stay 5 years)	£41,000
Tier 2 (Intra- Company Transfer)	Jobs which qualify for transfers of up to 9 years	£153,500
Tier 2 (General) and Tier 2 (Sportsperson)	Earnings which qualify for settlement (those working in PhD-level or shortage occupations are exempt)	£35,500 (for settlement applications made on or after 6 April 2018) £35,800 (for settlement applications made on or after 6 April 2019

*The minimum salary threshold for high earners able to benefit from an exemption to the cooling off period has also risen to £153,500.

 Transitional arrangements for Restricted CoS: revisions to the minimum salary thresholds mean that applications for Restricted CoS from the April 2014 allocation must be submitted between 6-16 April and will be decided on 17 April 2014.

Changes to Tier 1 General

 The Tier 1 General category will close to extension applications on 6 April 2015 and will close to settlement applications on 6 April 2018.

Changes to the Maintenance Requirement

 From 1 July 2014 the maintenance funds thresholds for points based migrants and their dependants will increase in line with general increases in the cost of living in the UK. A-rated Sponsors may still certify maintenance funds for Tier 2 migrants and their dependants.
